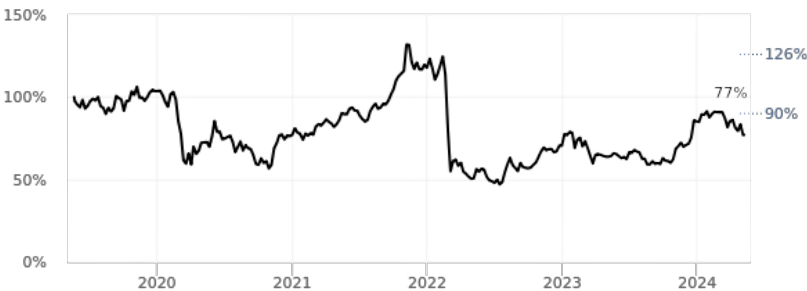

#### Price underlying (% of the starting value)



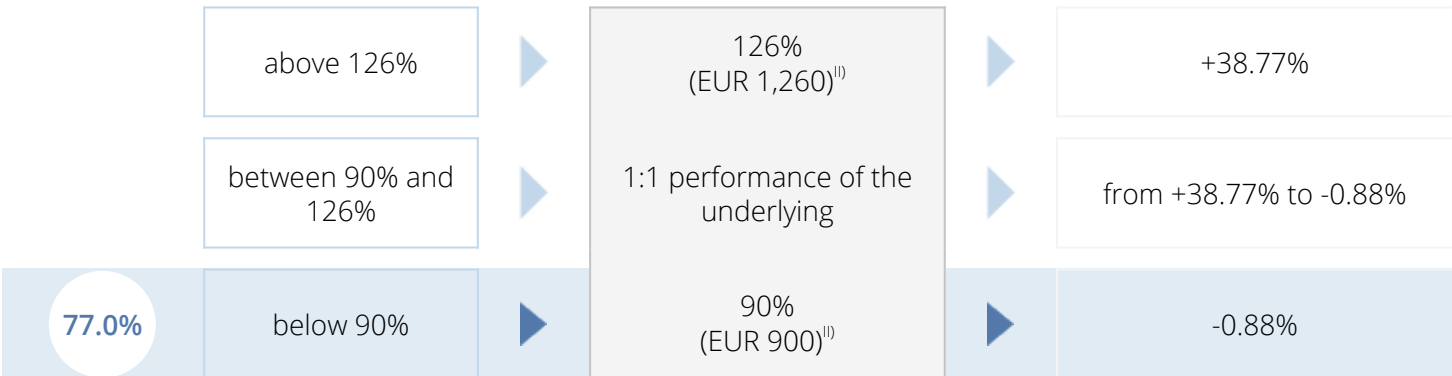

### The Certificate

The Raiffeisen Bank International Winner 90% certificate enables investors to participate at 100% in the performance of the Raiffeisen Bank International share at the end of the term.
