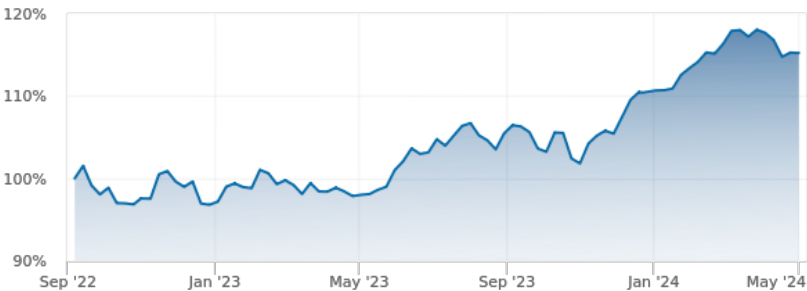

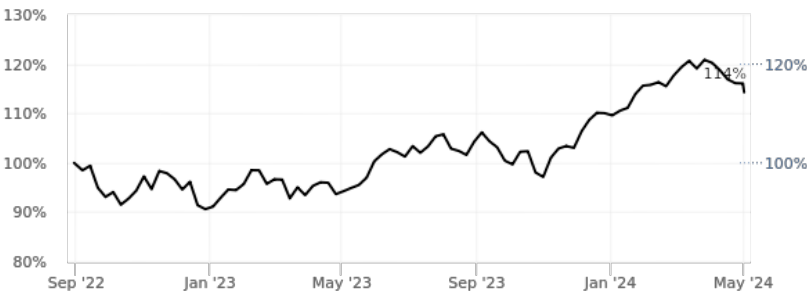

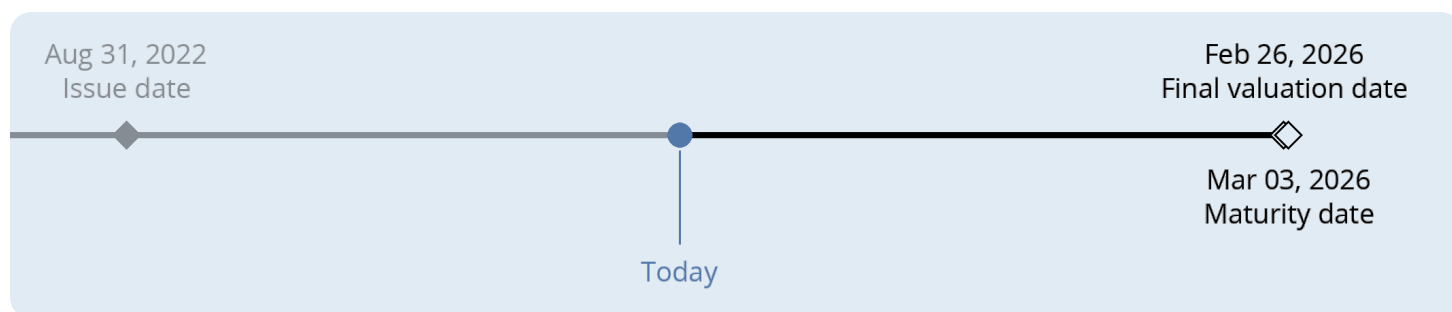
## The Certificate
