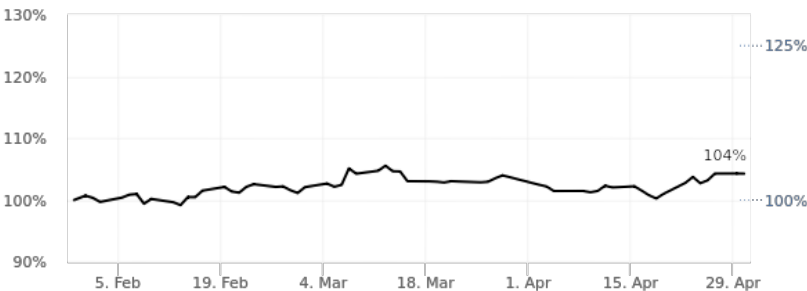

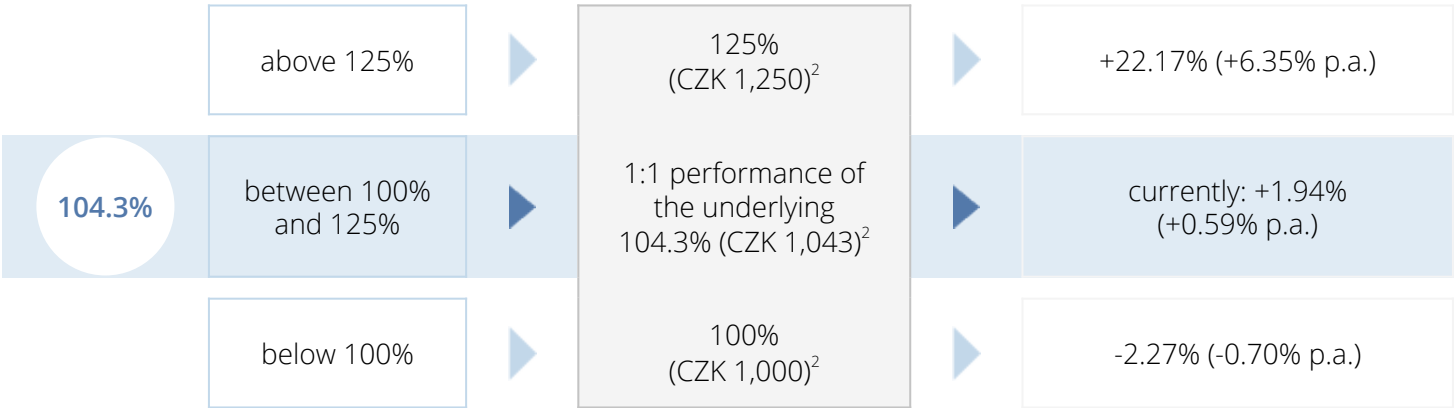

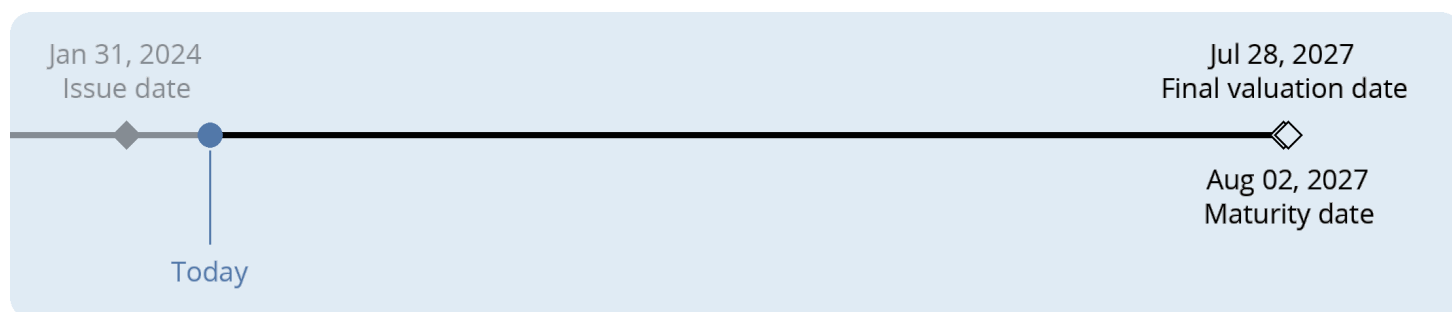
The Certificate
