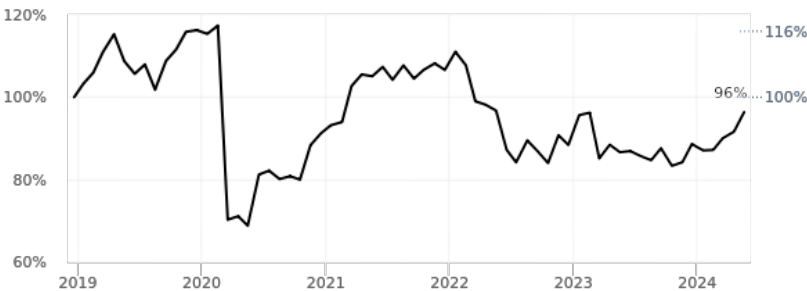

Price index: Dividends paid out are not reinvested in the index, but are used by the issuer to define the payout profile.
