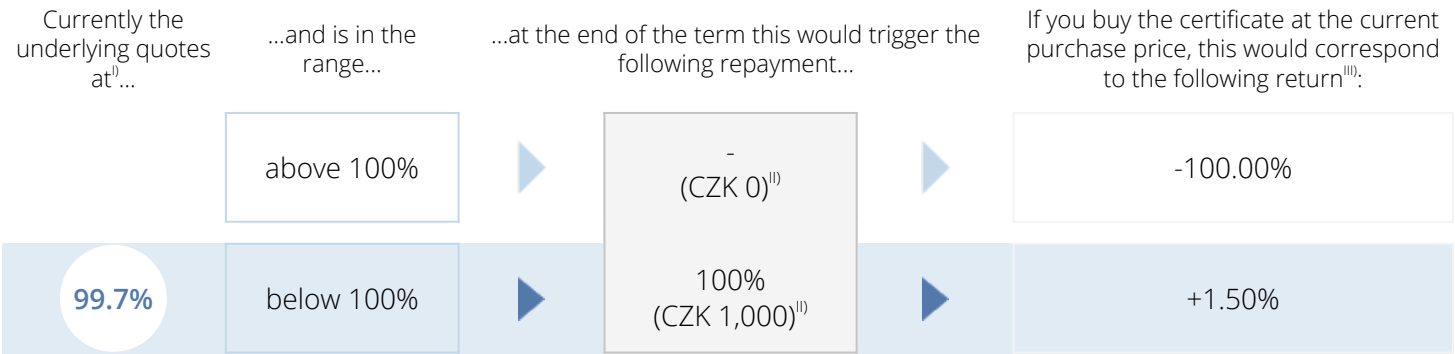

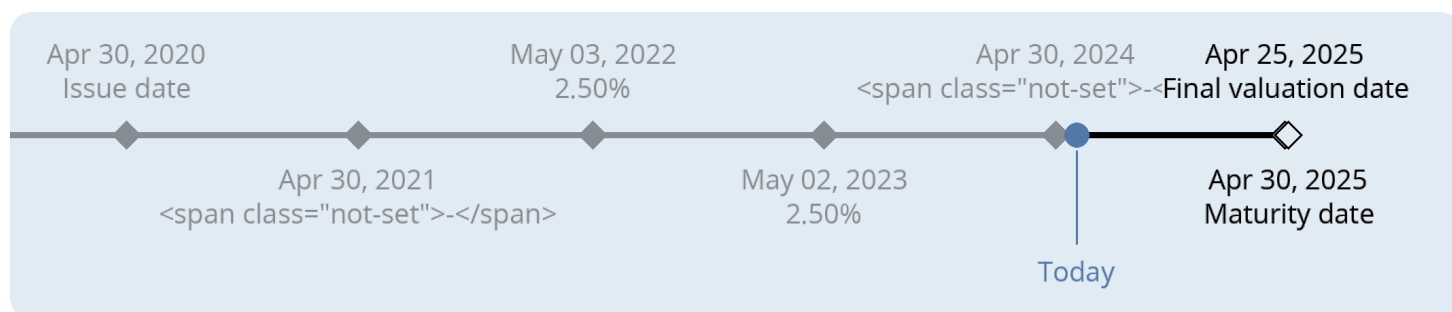
The Certificate
